**Sept 24-28** -- “Bring-a-Friend” week! Dancers are each allowed to bring one friend. IMPORTANT NOTE: Beautiful Feet requires a signed Liability Release form from a legal guardian before anyone's class participation – even “Bring-a-Friend” week guests. Please do not bring friends to company practice, as we will be working too much choreography.

**Oct 5** – Recommended date by which you would ideally have placed your order for Christmas recital costume items – this includes your uniform dance shoes!

**Oct 15-19** -- Costume bills will be emailed. Please notify us if you do not receive one  
Note: Costume bills will be emailed the week of Oct 15. These bills are for Spring recital costumes – you are responsible for purchasing your own Christmas recital costumes according to the guidelines provided in class (Christmas costumes must be approved by Julie by November 2). Spring recital costumes can range in price between \$40 and \$120. We will do our best to find inexpensive costumes, however, this is not always possible. Please be prepared to be flexible.

**October 13** – The Moscow Ballet will be holding auditions for "The Great Russian Nutcracker" to be performed at the Casper Events Center in December!
